- Section 1886(d)(3)(E) of Social Security Act
 - "For area differences in hospital wage levels by a factor"
- Areas defined by Core-Based Statistical Areas (CBSAs)
 - Office of Management & Budget (OMB)
 - Geographic reclassifications



- Wage index required to be updated annually
 - Short-term, acute care hospital info
- CMS applies a methodology to compute average hourly wage (AHW) compared to national AHW based on
 - Worksheets S-3, Part II, III, IV & V Form 2552-10



- Review process after cost report is filed
- Federal fiscal year (FFY) 2023
 - Cost reports beginning during FFY 2019 (9/30/2019, 12/31/2019, 6/30/20)
 - As filed data released mid-May, 2021
 - Revisions due to Medicare Administrative Contractor (MAC) in early September, 2021
 - MAC desk reviews in November, 2021
 - Preliminary Public Use File (PUF) in January, 2022
 - Basis for proposed Federal Register
 - Proposed Rule April May, 2022
 - Final Rule August September, 2022



- CBSA AHW/National AHW = Wage Index
 - Average is aggregate of all hospitals in the area
 - There are multiple issues—midpoint adjustment factor, occupational mix adjustment factor, budget neutrality adjustment
- The wage index is used to adjust the following Medicare payments
 - Hospital inpatient DRG
 - Hospital outpatient APCs
 - Skilled nursing facility
 - Hospice
 - Home health
 - Rehab
 - Psych







Wage Index Salaries - Worksheet S-3, Part II, Column 2

- From Worksheet A Column 1
- Should include
 - Regular pay
 - Vacation
 - Sick pay
 - Paid time off
 - Severance
 - Bonus



Wage Index Salaries - Worksheet S-3, Part II, Column 4

- Include
 - Regular hours
 - Paid overtime at 1.0 factor
 - Holiday pay
 - Vacation & sick leave
 - Paid time off
 - Hours associated with severance

- Exclude
 - On-call hours
 - Pay in lieu of time off hours
 - Shift differential units
 - Vacation & sick leave

CRNAs

- Line 2.00 Non-physician Anesthetist who is
 - Employed or contracted
 - Hospital has an exemption (granted pass-through)
 - Exclude non-labor items (equipment, supplies, travel, etc.)
 - If contracted, also report on Line 11
- Line 3.00 Non-physician Anesthetist salaries subject to fee sched



Physician Part A Salaries

- Line 4.00 Physician Part A salaries included in Line 1
 & Line 13.00 for Contracted Physicians
 - Medical directors
 - Administrative time
 - ER availability time
- Line 4.01 Teaching Physician salaries



Physician Part B & Other Salaries

- Line 5.00 direct patient care & billed under Part B time that's included in Line 1
 - E.g., physician, PA, NP
 - E.g., clinical nurse specialist
 - Physician salaries for patient care services for RHC & FQHC (Line 88's)
- Line 6.00 for non-physician RHC & FQH



Interns & Residents

- Line 7.00 Salaried I&R in approved program
 - If included on Worksheet A, Column 1, Line 21
- Line 7.01 Contracted I&R
 - Also include on Line 11, but not on Line 13
 - Exclude equipment cost, supplies, travel, etc.
 - Don't include costs related to excluded areas reported on Lines 9 & 10.00



Adjustment to Salaries

- Line 8.00 Home Office personnel
 - If included on Worksheet A, Column 1
 - This reduces salaries
 - If not on Worksheet A, Column 1, add Home Office on Line 14
- Line 9.00 SNF salaries from Worksheet A, Column 1, Line 44
- Line 10.00 Excluded area salaries from Worksheet A,
 Column

- Not just your general ledger "contract labor" accounts
- "The minimum requirement for supporting documentation is the contract itself"
- "Attestations or declarations from the vendor or hospital are not acceptable in lieu of supporting documentation for wages, hours, wage-related costs, and non-labor costs
- Must be grouped in the cost center to which you are seeking to include
 - A&G contract labor should be included in the A&G cost center.



- Line 11.00 Direct patient care
 - Patient care services
 - Exclude non-labor-related expenses such as equipment, supplies, travel, etc.
 - Exclude costs applicable to excluded area cost centers Lines 9.00 & 10.00
- Line 13.00 Physician Part A
 - Includes
 - Administrative time
 - ER physician availability
 - Supported by contracts and/or time studies



- Line 12.00 Management & Administrative
 - Contracted top level management
 - CEO, COO, CNO, CFO
 - Other contract management and administrative services
 - Patient care services department directors, administrators, managers
 - Includes ward clerks & medical secretaries

- A&G Line 28.00
 - Contract services that are included in Worksheet A, Line 5
 - Administrative and general functions
- Housekeeping Line 33.00
- Dietary Line 35.00

Wage Related Costs

- Detail reported on Worksheet S-3, Part IV
- Core benefits: Preprinted lines
- Lines 17 25 should match with types of salaries on Lines 1 10
- Line 18 wage related costs other is not completed on or after October 1, 2018
- Allocation basis is important
 - Salaries
 - FTEs
 - Combination
 - Direct assignment by department / cost center

Defined Benefit Pensions

- Pension costs equal the 3-year average of cash basis contributions
 - Two prior years
 - Current year
- 1/10th of prefunding balance through FFY 2022
- Pension cost schedule from CMS's website
- Pension plan fees reported separately



Health Insurance

- Self-insurance must be reasonable & in accordance with GAAP
- For health insurance, discount must be reasonable compared to other discounts accepted
- Added lines to indicate the type of health insurance
 - Line 8.01 Self-funded without a TPA
 - Line 8.02 Self-funded with a TPA
 - Line 8.03 Purchased health insurance

From Worksheet A general service cost centers

Follow same hours & salaries concepts

Grouping on Worksheet A is important

Allocated based upon the ratio of excluded hours to total hours



Wage Index Calculation

- Is the wage index average hourly wage reported on Worksheet S-3, Part III?
- AHW adjusted by cost report mid-point factor to inflate the cost report year to the current federal year
- AHW adjusted by occupational mix adjustment factor to account for labor pools available to providers
 - Occupational Mix Survey completed every three years
 - FFY 2022, 2023, & 2024 based upon 2019 OMS
- CBSA Adjusted Average Hourly Wage / National Average Hourly Wage








Wage Index Benchmarks






Wage Related Costs













Current Process in Many Hospitals





Example of Properly Functioning Cycle





- More than just contract labor
 - Hours
 - Physicians
 - Wage related costs
 - Pension
 - Health insurance
 - Allocation or direct assignment
 - Home office



- Involve payroll, human resource, accounts payable, and finance department
- Consider the impact of Worksheet A groupings
- Consider the treatment of Worksheet A-8 offsets versus nonreimburseable cost centers
- Determine what is taxed on W-2 and where it is recorded in the general ledger
- Get actual payroll hours by pay code and gain an understanding of pay codes
- Review vendor listing, not just general ledger review




- Contact vendors early and be persistent
- Incorporate contract labor hours into contracts
- Update physician agreements or contracts to state hours and dollars for services provided (Part A and/or Part B)
- Monitor physician time studies for completeness
- Obtain buy in from management for contract labor and physician time studies
- Include employee health expenses
- Evaluate employee benefit allocations or direct assignment



Impact of COVID -19 Pandemic

- Federal fiscal year (FFY) 2024
 - Cost reports beginning during FFY 2020 (9/30/2020, 12/31/2020, 6/30/21)
 - Higher wages
 - Overtime
 - · Increased nursing salaries
 - Increased patient care contract labor and dollars
 - COVID-19 impacted different CBSAs at different time frames
 - How will CMS respond in calculating the wage index?
